- 3. The selected Secretarial Auditors may be required to visit the units of the Company to check the compliance of applicable laws. SPMCIL shall reimburse the travelling expenses by train AC-II or by Air in economy class for a maximum of two persons and for single visit to each Unit. The stay arrangements shall be made in the guest houses at the units of the Company subject to availability or in the nearest hotel. The out of pocket expenses, if any shall be reimbursed on actual basis on production of bills / documentary evidence.
- 4. The filing fees on submission of e-form paid to MCA on behalf of SPMCIL shall be reimbursed on actual basis on production of receipt / challan by the PCS / Firm.
- SPMCIL is free to do conversion of Annual Accounts 2019-20 into XBRL in-house without taking assistance of selected PCS/Firm. SPMCIL is also free to engage any professional firm for doing other professional works to meet the statutory requirements from time to time on mutually agreed fees.
