

Terms and Conditions

- 1. Firm has to deploy 6 nos. of Security Guards (without arms) as per DGR terms & conditions for the period of two year after receiving the order from SPMCIL.
- 2. Firms are requested to quote as per DGR terms in sealed envelope. Bids shall be evaluated on the basis of all inclusive lump sum prices (inclusive of all). Among the Bidder with the lowest price quote (L1) shall be awarded the contract. However in case the L1 firm is non MSE, the price quoted by MSE firm within the range of L1+15% will be asked to match the price of L1 firm. In case the MSE firm matches the L1 price, order will be placed on MSE firm. However in case MSE firm does not match the price of L1 firm, the next lowest offer of MSE firm within the range of L1+15% will be asked to match the price of L1 and so on. In case no MSE firm (within the range of L1+15%) matches the price of L1 firm, order will be placed on L1 firm.
- 3. Security Deposit: The Bidder shall furnish the performance security amount/ Security Deposit (S.D) in the form of DD/Bank Guarantee (3% of the ordered value) valid up to sixty days after the date of completion of all contractual obligations by the supplier, within 21 days after issue of Notification of Award of Contract (NAC) by SPMCIL. DD/BG is to be submitted in favour of Security Printing & Minting Corporation of India Ltd payable at New Delhi. The format of Bank Guarantee is attached with this tender (Annexure-II). The performance BG will be returned without any interest to successful Bidder after the completion of all contractual obligations.
