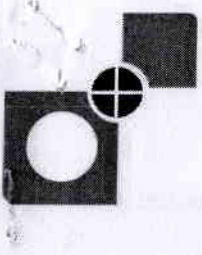

2(c)-1 Matter was concluded on 16.05.2019, File Number SPMCIL/VIG/531/16 and total number of pages (Noting-48 pages, Communication pages-516).

2(c)-2 Copy of complete file of vigilance cases cannot be authorized to be disclosed as these are confidential and sensitive in nature.
