2. DGM (S & C), SPMCIL post was advertised on 11-03-2006 and recruitment for the same was done in 2006. In this regard on the subject of recruitment of DGM (S & C), SPMCIL in 2006, the CVO SPMCIL prepared a investigation report/letter No. SPMCIL/Vig / 287 (Pt)/14/986, dated 19-5-2017.

There was pseudo-anonymous complaint of one Shri Purushottam Goyel as forwarded by C & C Division against Director SPMCIL and CMD SPMCII, who are Board level officials, vide C & C Division letter dated 19-9-2016 (Annexure-I). This complaint of Shri Purushottam Goyel as forwarded by C & C Division is further evident from first para of the Dy CVO, SPMCIL letter dated 4-10-2017 Annexure-II.

CVC Order No.006/VGL/ 065, dated 6-7-2006 (Annexure-III) prescribes the role of CVO SPMCIL in case of complaint against Board level officials. The relevant para is given below:-

"...While complaints against Board level officials are within the purview of the administrative Ministry's CVO, if it is referred to the CVO of the organisation under the Ministry, he should gather all factual information and submit the same to the Ministry's CVO. He is not required to make analysis or draw conclusions...."

In the above cited report dated 19-5-2017 (Annexure-IV), the CVO SPMCIL has made analysis and drawn conclusions against Board level officials, The report has further fixed responsibilities also in case of Baord level officials, vide para 9(b) and 9 (c) of the Report.
