Information provided:

C 6(a) - Complaint dated 29.10.2020 received vide email dated 29.10.2020 in CHO SPMCIL Vigilance Department, after perusal of the complaint it was found that complaint was related to RTI matter and concerned to IGM, Mumbai. Therefore, after approval of the competent authority i.e. CVO, SPMCIL, matter was forwarded to IGM, Mumbai vide letter dated 14.12.2020 for information & necessary action at their end and no action was taken in CHO SPMCIL Vigilance Department.

However, copy of letter, file noting and signature of the officials of vigilance cases cannot be authorized to be disclosed as these are confidential and sensitive in nature.
