The referred contract were placed on your firm for repairing, servicing of Samsung DVMS Air Conditioner with total cost of expenditure of Rs.2,29,215.00/-(including GST@18%) with delivery date 19.07.2021. However, your firm hadn't completed the services even after expiry of delivery period.

In connection with above referred letter dated 01.08.2022 and E-Mail dated 05.08.2022 was mailed to you regarding Non-completion of work/services. In return reply your firm had stated that your firm will start work on Monday. However no services/work completed by your firm. Thereafter vide our reminder email dated 08.09.2022 had reminded your firm to complete the services in reply vide your E-Mail dated 08.09.2022 and 09.01.2023 had requested to extend the time period till 16.01.2023 to complete the work. Hence, it is clearly states that even after providing several opportunities also your firm failed to complete contractual obligations and this seems to continuing with your firm may not be beneficial except loss of valuable time and efforts.
