Interested firms fulfilling the eligiblity criteria as given in Annexure 3 are requested to submit their offer as per format given in Annexure 4 of this tender. The tender must be submitted with the brief profile of the firm, their past performance in silimar operation, financial background etc. in support of the eligiblity criteria.

## Submission of Tender:

**Techno-commercial bid** and **Price Bid** are to be submitted in two separate envelopes on or before the due date of the submission of the tender as stated below otherwise tender/bid/quotation shall be liable for rejection.

#### Part- I: First Envelope should contain the Techno-commercial Bid

- iv. Payment terms.

#### **Background of the company**

Security Printing and Minting Corporation of India Limited (SPMCIL) is a Mini-Ratna Category-I CPSE and a wholly owned schedule 'A' Company of Government of India and is under the administrative control of Department of Economic Affairs, Ministry of Finance, Government of India.

SPMCIL is engaged in the manufacture of currency/security paper, Security Ink, minting of coins, printing of banknotes, non-judicial stamp papers, postage stamps, travel documents, excise labels etc. having nine units including four mints (India Government Mint-Kolkata; India Government Mint-Hyderabad; India Government Mint-Mumbai and India Government Mint-Noida), two security presses (India Security Press-Nashik and Security Printing Press-Hyderabad), two currency presses (Currency Note Press-Nashik and Bank Note Press-Dewas) and one paper mill (Security Paper Mill-Narmadapuram) across the country.

#### 1. Objective:

Empanelment of Consultant/Agency at various countries for representing SPMCIL in tenders related to Banknotes, Coins, Excise Labels, Revenue and Postage Stamps, Security Paper, Security Ink, Passport, Security Documents, Educational Certificates etc.

- 1.1. <u>Brief Description of Work</u> : SPMCIL is engaged in the manufacture/ production of Currency and Bank Notes, Security Paper, Non-Judicial Stamp Papers, Postal Stamps & Stationary, Travel Documents viz. Passport and Visa, Security certificates, Cheques, Bonds, Special Certificates with security features, Security Inks, Circulation & Commemorative Coins, Medallions, Refining of Gold & Silver, and Assay of Precious Metals.
- 1.2. SPMCIL intends to participate in tenders issued by the authorities of various countries. Accordingly, the firms who are engaged in providing consultancy for export business in the country for which they are participating may apply for empanelment through this tender.
- 1.3. The Consultant/Agency will identify business opportunities for SPMCIL, particularly aligned to their own region. They will be responsible for developing appropriate relationships with external parties to help develop opportunities and winning tenders, to meet SPMCIL objectives and work with SPMCIL to develop customer solutions and prepare responses.
- 1.4. The role will also involve overseeing all commercial & technical aspects in accordance with SPMCIL procedures.
- 1.5. Assisting in preparation of bidding documents and proposals and also verifying the bid documents before submission.
- 1.6. Tracking progress of Evaluation for project and replies to any queries.
- 1.7. Assistance and guidance during the contract negotiation and getting signed the contract in SPMCIL favor.
- 1.8. Assisting with execution for the contract. Working to facilitate the smooth execution of the contract and realization of payments with the clients in favor of SPMCIL.
- 2. The Consultant/Agency should have the basic facilities and expertise in similar work at global/national level in that particular country.
- 3. The empanelment shall be for tenders issued by authorities of the country for which the Consultant/Agency has applied for empanelment and shall be valid for three years.
- 4. The selected firm shall be required to sign "Non-disclosure Agreement" with SPMCIL.

#### Eligibility Criteria

**1.** <u>Status:</u> The applicant should be proprietary firm/ Limited Liability Partnership (LLP)/company/Partnership/ (legal entity) registered under relevant regulation of the respective Country. The applicant should be in business of providing consultancy for export business in various countries.

## 2. <u>Experience:</u>

- a) The applicant should have provided similar type of services across the globe/country during the period of last five years ending on <u>31<sup>st</sup> March 2022 or</u> <u>31<sup>st</sup> December 2021 (as the regions accounting standards)</u>. The details for the same should be submitted along with documentary evidence.
- b) The interested bidders should also submit along with tender a list of parties to whom they have supplied similar type of services (consultancy of export business) with details and customer satisfaction report from their clients.

## 3. <u>The bidder should also confirm specifically that:</u>

- a) Applicant is competent and legally authorized to submit and/or to enable into legally binding contract.
- b) The firm should confirm their annual capacity for similar type of services (consultancy of export business).
- c) Applicant will absolve SPMCIL against any infringement of patent rights and other contract provisions.
- d) The bidder should not be representing other organization who is competitors of SPMCIL. An undertaking in this regards needs to be submitted along with the offer.
- **4.** The bidder firm should have not been blacklisted / debarred by any Organization/Government for participation in tender as on the last date of submission of Tender. An undertaking for the same shall be furnished.
- **5.** The copy of audited balance sheet and Profit and loss account for last three financial years ending <u>31<sup>st</sup> March 2022 or 31<sup>st</sup> December 2021 (as the regions accounting standards)</u> are to be submitted along with the proposal.
- **6.** All documents are to be submitted in English language only. If the documents are in other language English translation copy shall be furnished along with the documents.
- **7.** The proposed business entity should have been established for at least 05 years in country for which the empanelment is applied and corresponding proof in the form of valid address of registration of the firm with the local authorities should be provided.

#### 8. <u>Selection Criteria</u>

8.1 In the 1st stage the offers shall be evaluated based on the experience criteria and the list of suitable bidders shall be forwarded to Indian Embassy in the country for which the empanelment is applied for verifying the credential of the firms.

8.2 On the basis of the verification report of Indian Embassy in country for which the empanelment is applied, the price bid of the only approved firms shall be opened and the successful applicant shall be selected **as per Quality and Cost Based System (QCBS) of evaluation in the ratio of 30:70 (30% Technical and 70% Financial)** as mentioned below.

## 8.3 Evaluation of Technical Bids and Short-listing of Applicants

The Technical Proposal will be evaluated in the 1<sup>st</sup> stage and the applicants shall be ranked as per score achieved by them, from highest to the lowest technical score (ST). The scoring criteria to be used for evaluation shall be as follows:

## 8.4 Evaluation of Financial Proposal

In the Second stage, the financial evaluation will be carried out. For financial evaluation, each Financial Proposal will be assigned a financial score (SF). The lowest Financial Proposal (FM) will be given a financial score (SF) of 70 points. The financial scores of other bids will be computed as follows:

SF = 70 x FM/F (F = amount of Financial Proposal)

## 8.5 Combined and Final Evaluation

Bids will finally be ranked according to their combined technical (ST) and financial (SF) scores as follows:

 $S = ST \times TW + SF \times FW$ 

Where, TW and FW are weights assigned to Technical Proposal and Financial Proposal that shall be 0.30 and 0.70 respectively.

The Selected Applicant shall be the Applicant having the highest combined score. The second highest Applicant shall be kept in reserve and may be invited in its discretion for negotiations in case the first-ranked Applicant withdraws, or fails to comply with the requirements as the case may be.
