ISP, Nasik has issued above referred PO to your firm i.e. M/s. Olive Export Pvt Ltd., Delhi, for supply of LED Street Light Fittings, you have not provided replacement against the following defective LED street light fittings under warranty:

Therefore, in view of poor performance (**Not providing replacement of defective material under warranty**); by intimating Un-suitability of material, a Show Cause notice vide ISP Letter No. SY-13-30(02)/2020/6669 dated 10.03.2022 had been issued to the firm and requested to furnish explanation as to **why ISP PO no.4500018395 dated 20.10.2020 should not be terminated and administrative action including forfeiture of SD, Ban and blacklisting should not be taken against your firm.** In response to the Show Cause Notice issued by ISP, Nashik, it was informed by you vide email dated 12.03.2022 that, you are arranging spares against the faulty lights.

3. However, the replacement were not provided. Accordingly, vide ISP letter no. SY-13-30(02)/2020/2341 dated 18.07.2022 it is was again requested to provide replacement for the above defective material within 7 days otherwise administrative action as deemed fit including forfeiture of SD, Ban and blacklisting will be taken against you firm.

4. Since, this is violation of the terms and conditions of the PO and tender. Accordingly, in view of the poor performance of the firm (**Not providing replacement of defective material under warranty**), by terminating ISP PO No. 4500018395 Dated 20/10/2020 on your sole responsibility, the firm M/s. Olive Export Pvt Ltd., Delhi, is Put on Holiday List (Temporary Debarment or Suspension) to participating in the tender of India Security Press, Nashik and any of the units of SPMCIL for a period of One(01) Year with effect from 18/08/2023 and Security Deposit (Rs.71,232/-) submitted by you has been forfeited.
