K B Sales, Nashik and principal manufacturer M/s Threads (India) Pvt Ltd, Kanpur on Holiday list for period of 12 months with forfeiture of Performance Security Deposit-reg.


Sir,

ISP-Nashik issued above referred GeM contract to your firm i.e. M/s. K B Sales, Nashik and principal manufacturer M/s Threads (India) Pvt Ltd, Kanpur for supply of Multi colour Ultra Violet Thread; quantity 3000 reels. The delivery schedule as per terms and conditions of GeM contract was as under:

2. As per the Delivery Schedule, firm M/s. K B Sales, Nashik (Principal Manufacturer M/s Threads (India) Pvt Ltd) had supplied 12 Reels of Multi-colour Ultra Violet Thread under Invoice No. KBS/293/2023-24 Dated 15.07.2023 which was tried on machine and found unsuitable for ISP use. ISP vide letter No. SY-6-8/2022/3033 Dated 09.08.2023 requested to supply the pre-production sample exactly as per tender specification and informed that in case the pre-production sample again found unsuitable, the order will be cancelled and also suitable disciplinary action including ban and blacklisting will be initiated against them.

3. M/s. K B Sales, Nashik had again supplied 12 Reels of Multi-colour Ultra Violet Thread as a pre-production sample under invoice No. KBS/76/2023-24 Dated 01.10.2023 & the same was tried on machine and again found that the performance of material was not satisfactory during machine trial as the thread kept breaking and the amount of cotton fly was significantly high and hence again found unsuitable for use.
4. Accordingly, ISP vide letter No. SY-6-8/2022/5009 Dated 29.10.2023 issued show cause notice to M/s. K B Sales, Nashik (Principal Manufacturer M/s Threads (India) Pvt Ltd) intimating the firm about the rejection of the material. Further, firm was asked to submit the explanation that as why the disciplinary action including termination of contract & Holiday listing/ ban / blacklist and forfeiture of security deposit should not be initiated against firm for not supplying the Pilot batch / pre production sample as per Technical Specification of GeM bid and GeM Contract No. GEMC-511687759211772 dated 15.06.2023.
5. In response, the firm M/s. K B Sales, Nashik (Principal Manufacturer M/s Threads (India) Pvt Ltd) submitted their reply vide their letter No. Nil dated 02.11.2023 which was not found satisfactory.
6. Accordingly, M/s. K B Sales, Nashik (Principal Manufacturer M/s Threads (India) Pvt Ltd) has failed to supply the material as per technical specification of GeM bid and GeM contract. This is complete violation of terms and conditions of GeM contract and GeM bid due to repeated non performance.
7. In view of the above non-performance, your firm viz. M/s. K B Sales, Nashik and principal manufacturer M/s Threads (India) Pvt Ltd, Kanpur is put on Holiday List (Temporary debarment or suspension) to participate in the tenders of India Security Press, Nashik and any of the units of SPMCIL for a period of one year with effect from 20.11.2023 and Security Deposit amounting Rs.1,36,760/- submitted vide FDR No. 42017303120 Dated 30.06.2023 issued by State Bank of India, Devlali Branch has been forfeited. Further, the said-GeM contract No. GEMC-511687759211772 dated 15.06.2023 has been terminated.
8. No further correspondence in this regard will be entertained.
