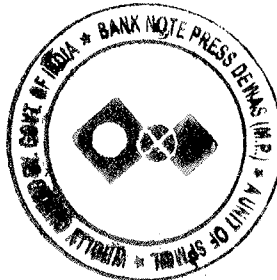
BNP Dewas has floated GeM bid No. GEM/2025/B/5985104, dated 28-02-2026 for procurement of 4nos Battery Operated Pallet Trucks. GeM contract no. GEMC- 511687787548166 dated 24.05.2025 placed to the firm M/s M/s. Stackers & Movers (I) Mfg. Co., Gujrat of value Rs.13,92,000/-. However, despite reminder emails and show cause notice dated 20.11.2025, 06.05.2026 and 29.06.2026 firm is failed to resolve the issue occurred in the supplied battery operated pallet trucks during the warranty period even after giving reasonable chances.

2. In line with the terms & conditions of GeM Contract and SPMCIL Procurement manual guidelines, your firm stands debarred from participating in any of the tender/GeM bid of Bank Note Press Dewas for a period of "One Year" wef dated 16.08.2026 to 16.08.2027.

3. And also, Security deposit/performance security of Rs. 69,600/- submitted by the firm is forfeited (In form of Bank Guarantee No. 25621GF251101530 dated 03.07.2025 from Kotak Mahindra Bank Ltd.)
