महोदय/Sir,

- Please refer to above mentioned GeM Bid, GeM Contract, Purchase Order and Amendment Letter and show cause letter for hiring of conservancy services for ISP Estate and Nehru Nagar.
- It is to inform that for the above mentioned contract of Conservancy Services your firm is providing 31 nos. of Semi-Skilled Manpower. The original duration of contract is from 08.03.2025 to 07.03.2026. Further it is to inform that vide Amendment Letter No. 94 dated 26.02.2026 the contract has been extended for three months from 08.03.2026 to 07.06.2026.
- In this connection, it is submitted that the firm has not made the payment of wages to contract labour workers from the month of March-2026. Therefore vide e-mail dated 17.03.2026 ISP directed your firm to release the payment of wages of Contract Labour Workers. In reply, firm has informed that their contract was completed on 07.03.2026 and it was extended without consent of the firm. However, as per clause no. 2.1 of GeM Contract states that, "The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. **Bidders are bound to accept the revised quantity or duration**".
- Further vide e-mail dated 18.03.2026, 17.04.2026 & 18.04.2026 your firm was again directed to disburse the wages to the Contract Labour Workers. However till date your firm has not made the payment of wages to the Contract Labour Workers of Conservancy, of ISP Estate.
- This discrepancy is a significant breach of the GeM Contract No: GEMC-511687745093769 dated 22.02.2025 place on your firm.
